Schooner captain from Northport, Maine

Accounts, bills, charter parties, wage receipts, correspondence, and other documents from vessels commanded by Captain William F. Hopkins between 1887 and 1909. The bulk of these are from the schooner STAR OF THE SEA, which Hopkins sailed in the 1890s. The collection provides a detailed record of the businesses and sailors involved in the coal, lumber, phosphate, and sugar trades between New York, Philadelphia, southern US ports, and the Caribbean.

Acquisition:

This collection was donated to Penobscot Marine Museum by the family of Robert P.L. and Elizabeth W. McLain in 2003. The McLain family found the papers in the attic of their house in Northport, Maine, which had previously been owned and occupied by Captain William F. Hopkins.

Restrictions:

This collection is open to research. There are no special restrictions.

Condition:

The papers are mostly in good condition. Some have mouse damage, have started to yellow, or have slightly battered and torn edges. Many of the bound volumes have fairly heavy

damage to the covers and bindings from mice, silverfish, and other pests. However, the text blocks remain intact and legible.

Processing Note:

The documents have been unfolded, flattened, and rehoused, but otherwise minimally processed since acquisition.

Historical Note:

William F. Hopkins was born in 1859 in Hampden, Maine. He moved to Northport, Maine, as a child, and, with his brothers, started a career at sea. He spent his career in the coasting and West Indies trades, carrying bulk cargoes of coal, lumber, phosphate rock, ice, and sugar to ports in New England, the mid-Atlantic, Gulf of Mexico, Cuba, and other Caribbean islands. By 1889, Hopkins was a captain aboard the schooner F.H. ODIORNE, owned by W.F. Green & Sons of Boston. In 1891, he took command of W.F. Green's schooner STAR OF THE SEA, followed by the schooner SENATOR SULLIVAN in 1900. Hopkins' last vessel was likely the schooner VIKING of New York, which he sailed from 1907 to 1911.

William F. Hopkins married Clara A. Crockett (1872-1954) in 1891. They had no children, but lived with Clara's family in Northport. Hopkins died in 1923.

Scope & Content:

This collection contains bills, receipts, accounts, correspondence, charter parties, and other business records from the schooners STAR OF THE SEA, SENATOR SULLIVAN, and VIKING during the years they were commanded by Captain William F. Hopkins. It provides a highly detailed record of Hopkins's participation in the coastwise coal, lumber, phosphate, and sugar trades, but little personal material.

A majority of the documents in this collection are accounts, bills, receipts, and other records from the various brokers, chandlers, customs agents, and other firms involved in handling a vessel's business in port. Charter parties and bills of lading provide a fairly complete record of the merchants and cargoes that Hopkins worked with. The collection is particularly detailed regarding seamen: there are receipts for wages paid to nearly every crewmember that Hopkins shipped over fifteen years, as well as some more detailed slop accounts in which Hopkins kept track of individual sailor's cash advances and clothing and tobacco purchases. Business correspondence tends to be brief and direct; much of this is from William F. Green & Co., Hopkins's managing owners in Boston, and merchants that Hopkins worked with in other ports.
