Ship brokers, commission merchants, chandlers, and grocers in New York, NY.

Business records of Swan & Son, a ship brokerage and commission merchant in New York City. The bulk of the collection consists of papers from 22 vessels owned by Swan and Son, including bills and receipts, official documentation from foreign ports, vessel repairs and medical care for the crew, correspondence from ships' captains reporting on voyages, and applications for admission to the Sailors' Snug Harbor. There are also records from the Swan & Sons' ship brokerage and two ledgers from the associated ship chandlery and grocery, William H. Swan.

#### **Acquisition:**

The papers in this collection were kept by the William H. Swan Ship Chandlery until the 1980s. They were purchased by the Penobscot Marine Museum in 1989.

#### Restrictions

This collection is open for research. There are no special restrictions.

#### Condition:

Papers are in good condition, with wear commensurate with age.

#### **Historical Note:**

Swan & Son was a ship brokerage operated in New York City by William and John Swan. The related William H. Swan, Ship Chandlery and Grocer, was founded in 1874 by William H. Swan, John's father. In addition to arranging cargoes and supplying other vessels,

the company also owned and managed ships on its own account. Swan and Son vessels were engaged in foreign trade, carrying cargoes such as lumber, cement, rice, hemp, sugar, railroad ties, guano, coal, sand and hay to and from places such as South America, Cuba, Barbados, the Philippines, South Africa and New Zealand. Swan and Son probably operated as a brokerage into the 1940s. The chandlery was in business until the 1980s.

#### **Scope and Content:**

The bulk of the collection is 9.45 cubic feet of records from 22 vessels owned by Swan and Son, Ships Brokers and Commission Merchants, including bills and receipts, official documentation from foreign ports, vessel repairs and medical care for the crew, correspondence from ships' captains reporting on voyages, and applications for admission to Sailors' Snug Harbor. Thirteen of the vessels were built in Maine. Vessels mentioned include the barkentine EMITA, barkentine MANNIE SWAN, bark GLENEIDA, brig HAVILAH, bark DAISY READ, brig LEONORA, and barkentine JOHN SWAN.

The collection also has contains 0.7 cubic feet of business records for Swan and Son, Ship Brokers and Commission Merchants, including bills and receipts, check ledgers and real estate transactions. Two ledgers record the accounts of the associated company William H. Swan, Ship Chandlery and Grocer, 1875-1879 and 1889-1891.
